Overnight express mail entries must have the acceptance signature waived. Entry form changes, additions, corrections and cancellations MUST be received in writing or via e-mail prior to the closing of entries, be legible, and include the AKC number of dog, or no refunds will be issued. No verbal changes accepted. Entries will not be accepted without fees. Canadian exhibitors must submit entries with checks drawn on U.S. accounts or with international money orders payable in U.S. funds. Post-dated checks and returned checks do not constitute a valid entry fee. The Secretary will add a collection fee of \$35.00 to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY basis. # NOTICE TO EXHIBITORS

- These trials are open to all AKC registered breeds.
- An entry for a dog for more than one day **MUST** be identical. If a dog is to be entered in different classes each trial, use a separate entry form for each trial.
- Owners are responsible for completing entry forms correctly. Owners are responsible for errors on the entry forms and no entry fee will be refunded in the event of such errors or cancellations of entries after the published closing date.
- The Show Committee and Show Secretary will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in these trials.
- Dogs must be on leash or confined to their crates, except when competing. When handlers are not present crates must be secured on all sides.
- Dogs are not required to be at the trial until the scheduled time of judging. All dogs not needed for further judging are excused. The owner or handler of each dog is solely responsible for having the dog ready at ringside when the class is to be judged.
